# Report on the progress made in attaining the goals of the wellness policy (REQUIRED): Since the implementation of our updated Wellness Policy in December of 2021, Urban Academy has made meaningful progress in fostering a healthier environment for students. Key accomplishment include: 1. Public Involvement and Accessibility: A triennial assessment was completed and results were made publicly available on our website. Outreach efforts continue to encourage stakeholders participation in the Wellness Committee, with the next meeting planned for Q1 of 2025. 2. Nutrition Education and Promotion: Nutrition education has been integrated into various grade levels and subjects. We are researching local partnerships to promote participation in school meal programs. 3. Physical Activity and Education: Opportunities for physical activity have been provided, including before- and after-school programs and recess. We have maintained efforts to provide a supportive and safe physical environment that promotes physical activity. 4. School-Based Wellness: Safe, clean drinking water is available and safe meal environments are ensured. All nutrition staff complete professional development on an annual basis to align with federal and state standards. 5. Nutrition Standards Compliance: School meals meet federal nutrition guidelines, and healthy options are promoted. Progress continues to align fundraisers and other offerings with Smart Snack standards. The upcoming Wellness Committee meeting in Q1 2025 will address gaps identified in this assessment.
